Eligible entrants:	Entry is only open to Australian residents who are 18 years of age or over.		
How to Enter:	To enter the Promotion, the entrant must complete the following steps during the Promotional Period: a) purchase two (2) of any participating products (as advertised in venue) in one (1) transaction or a jug, to share, from any venue displaying advertising for this Promotion ("Participating Venues") and collect a game card at the time of purchase, while stocks last; and b) scratch the game card to reveal whether or not they have won a prize. Instant win prizes available to be won are listed below. Each Participating Venue will be provided with one (1) or more kits. Each kit will contain 1,500 game cards (includes 500 winning game cards). Employees (and their immediate family members) of the Participating Venues, agencies/companies directly associated with the conduct of this Promotion, the Promoter, businesses involved in determination of winner/s for the Promotion, businesses involved in the management of the Promotion, any organisation benefiting from the Promotion, the Promoter's distributors, suppliers, subsidiary companies/businesses and associated companies and agencies are not eligible to enter.

If for any reason any aspect of this Promotion is not capable of running as planned, including by reason of computer virus, communications network failure, bugs, tampering, unauthorised intervention, fraud, technical failure or any cause beyond the control of the Promoter, the Promoter may, in its sole discretion, cancel, terminate, modify or suspend the Promotion and invalidate any affected entries, or suspend or modify a prize, subject to State or Territory regulation.
